Minutes from the Annual General Meeting held on Tuesday 28th March 2023 at 7.30 p.m.

1. Apologies for absence: Gill Smith, Carol Southern

Dave welcomed attendees to the meeting and thanked the committee for their help and support during the last year. No villagers attended.

2. Approval of Minutes of Last Meeting

• The Minutes of the AGM held on 22nd March 2022 were approved and signed by Dave Smith. Proposed by: Carol Stead Seconded by: Peter Sharpe

3. Matters Arising from the minutes of the last Annual General Meeting

- Dave Smith reported the issues over the water bill have been resolved.
- Dave Smith has put postings in The Villager and Facebook in an attempt to drum up volunteers but these were unsuccessful.
- A discussion ensued of village organisations who use the hall and have no representative on the VH committee. It was felt that any organisation within the village operating for the benefit of parishioners should be offered the opportunity to serve on the committee to support the running of the hall.

4. Treasurer's Report and presentation of accounts

- £17,300 = total receipts. £2667 was the last of the Covid grant. Cricket club correction.
- Letting incomes increased by just over 50% (coming out of lockdown).
- Nathan asked what the £200 in restricted funds referred to, but Dave did not know.
